Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

The Allotment Committee of the Board of Directors of the Company at its meeting held today, has approved an allotment of 13,931 equity shares of Rs.10/- each, being the exercise of 375 equity stock options under the Employee Stock Option Scheme, 2009 Plan A (ESOS 2009 – Plan A), 3,283 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B (ESOS 2009 – Plan B), 9,804 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013) and 469 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014).
