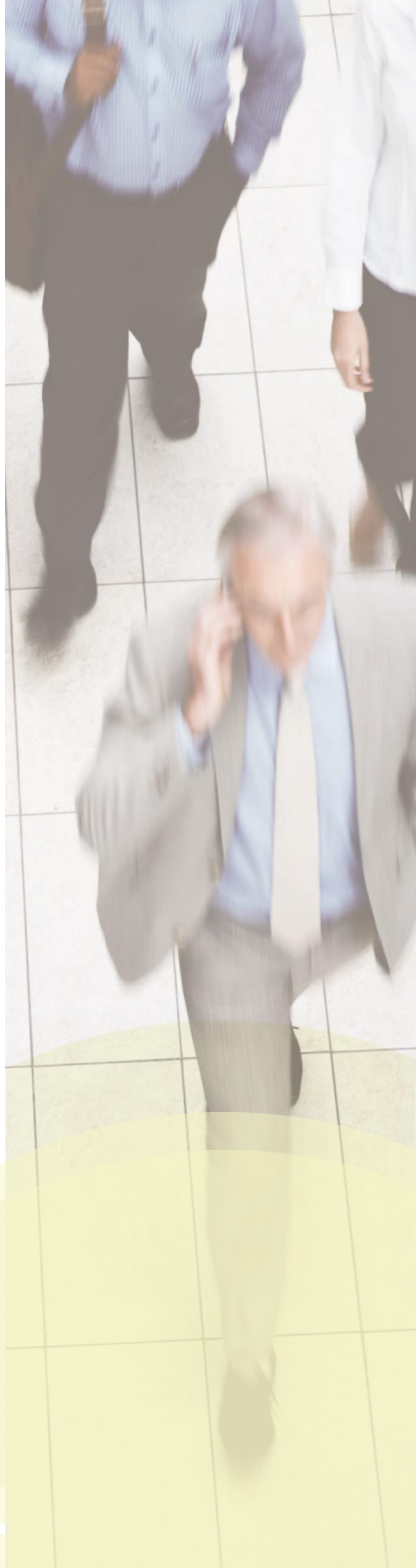

Who Is This Vendor Assessment For?

NelsonHall's payroll services vendor assessment for Ramco is a comprehensive assessment of Ramco's payroll service offering and capabilities, designed for:

- Sourcing managers monitoring the capabilities of existing suppliers of payroll outsourcing and identifying vendor suitability for payroll process outsourcing RFPs
- Vendor marketing, sales, and business managers looking to benchmark themselves against their peers
- Financial analysts and investors specializing in the support services sector
- HR and payroll decision makers.

Key Findings & Highlights

Ramco Systems (Ramco) is a publicly listed software and services company, and part of the Ramco Group of companies. It is headquartered in Chennai, India with ~1.6k employees and 21 offices across India, APAC, ANZ, U.S., Canada, Europe, Middle East and Africa. Ramco offers multi-tenanted HCM and global payroll cloud and mobile based enterprise software and services.

Ramco has ~20 years' experience in delivering payroll software and services, initially using client-server architecture. In 2008 it began investing in cloud technologies as part of a company-wide strategy to move all proprietary software into a cloud architecture. It has one HCM product, called Ramco HCM.

As well as the payroll cloud offering, Ramco also offers managed payroll services and MPHRO services which include HR administration and employee helpdesks. Its HCM cloud offering is adopted by ~40% of all client employees payrolled, with the remaining 60% on on-premise software.

Ramco provides payroll services for ~326k employees and produces ~1.5m payslips annually across the globe.

Payroll is focused on and generates revenue across:

- Asia Pacific, led by India, followed by mainland Australia
- U.S.
- MEA.

Ramco has ~375 employees dedicated to delivering payroll services. Approximately 70% of these dedicated payroll employees are based in offshore service centers, ~20% are based in nearshore or onshore locations, and an additional ~10% are based on client site.
