Sub: <u>Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements)</u> Regulations, 2015

The Allotment Committee of the Board of Directors of the Company at its meeting held today, has approved an allotment of 27,270 equity shares of Rs.10/- each, being the exercise of 6,294 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B, 16,378 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013) and 938 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014).
