- Pursuant to the receipt of the consent from the shareholders for the sale of Secure Converged Networking (SCN) division of the Company to its wholly owned subsidiary Ramco Infotech Solutions Limited (RITS), the SCN division has been transferred to RITS with effect from 1st April, 2006 for a consideration of Rs.11.88 crores, being the book value of the net assets of the division as at the commencement of 1st April, 2006, to be settled by the issue of 3,839,122 equity shares of Rs.10/- each at a premium of Rs.13/- each aggregating to Rs.8.83 crores and by way of cash to the extent of Rs.3.05 crores. Accordingly, the above results as well as the segment reporting results given below, for the quarter and for the six months ended 30th september 2006, reflect the performance of the Company, excluding the SCN division. In view of this, the said results for the previous period/year are not comparable with the figures for the current period/year. current period/year.
