The Allotment Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 8,362 equity shares of Rs.10/- each, being the exercise of 5,245 equity stock options under the Employee Stock Option Scheme, 2008 (ESOS 2008), 99 equity stock options under the Employee Stock Option Scheme, 2009 - Plan A, (ESOS 2009 -Plan A), 18 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B (ESOS 2009 -Plan B) and 3,000 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013).
