## <u>Sub:</u> Allotment of Shares under Company Employee Stock Options Schemes Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

The Allotment Committee of the Board of Directors of the Company at its Meeting held today, had approved the allotment of 12,089 equity shares of Rs.10/- each, being the exercise of 839 equity stock options under the Employee Stock Option Scheme, 2008, (ESOS 2008), 2,850 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013) and 8,400 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014).

The meeting commenced at 01.00 P.M. and concluded at 01.15 P.M. The Company shall apply for the listing and trading permission shortly.
