The Allotment Committee of the Board of Directors of the Company at its meeting held today, has approved an allotment of 7,758 equity shares of Rs.10/- each, being the exercise of 175 equity stock options under the Employee Stock Option Scheme, 2008 (ESOS 2008), 177 equity stock options under the Employee Stock Option Scheme, 2009 - Plan A, (ESOS 2009 -Plan A), 56 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B (ESOS 2009 -Plan B) and 7,350 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013).
