- ii) The National Stock Exchange of India Limited vide their letter No.NSE/LIST/252668-7 dated 13<sup>th</sup> October, 2014 for ESOS 2013, letter No.NSE/LIST/252389-U dated 9<sup>th</sup> October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
