## Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

The Allotment Committee of the Board of Directors of the Company at its meeting held today, has approved an allotment of 214,327 equity shares of Rs.10/- each, being the exercise of 68,466 equity stock options under the Employee Stock Option Scheme, 2009 - Plan A, (ESOS 2009 - Plan A), 79,730 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B (ESOS 2009 - Plan B) and 66,131 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013). The allotment includes allotment of 66,966 equity shares under ESOS 2009 - Plan A, 35,312 equity shares under ESOS 2009 - Plan B and 20,626 equity shares under ESOS 2013, aggregating to 122,904 equity shares to Shri A V Dharmakrishnan, Non-Executive Director. Consequent to this the paid up equity share capital has increased from 30,129,353 equity shares of Rs. 10/- each to 30,343,680 equity shares of Rs. 10/- each. - ii) The National Stock Exchange of India Limited vide their letter No. NSE/LIST/130925-N dated 17th February, 2010 for ESOS 2009 Plan A, letter No. NSE/LIST/132317-R dated 8th March, 2010 for ESOS 2009 Plan B and letter No. NSE/LIST/252668-7 dated 13th October, 2014 for ESOS 2013.

The meeting commenced at 4.00 p.m. and concluded at 4.15 p.m.

The Company shall apply for the listing and trading permission shortly.
